### ORDER:

The Managing Director, Andhra Pradesh State Housing Corporation Limited, in the letter 2nd read above stated that the Government of India communicated revision of unit assistance provided to Rural BPL households for construction of houses under Indira AwaasYojana (IAY) as Rs.75,000/- in hilly/difficult areas, including Integrated Action Plan (IAP) districts and in other areas as Rs.70,000/- in each unit and that 4% of funds for administrative expenses will be made available to the State Governments.

2. Further, the Managing Director, Andhra Pradesh State Housing Corporation Limited has requested the Government to enhance the unit cost in Rural Housing Schemes from existing unit cost of Rs.45,000/- to Rs.70,000/- on par with IAY Housing Programme and for Urban Housing Scheme from Rs.55,000/- to Rs.80,000/- per unit.

3. Government after careful examination of the circumstances stated by the Managing Director, A.P. State Housing Corporation Limited, in his letter 2<sup>nd</sup> read above, hereby enhance the unit cost of Rural Permanent Houses ( RPH ) from Rs.45,000/- to Rs.70,000/- and Urban Permanent Houses ( UPH) from Rs.55,000/- to Rs.80,000/- . The Financial pattern of the unit cost is as shown below:

4. Payment under the enhanced unit cost of housing for in progress houses will be in proportion to the stage of completion.

5. The orders issued in G.O.Rt.63, Housing (RH.A2) Department, dt.21.03.2013 regarding construction of Individual Sanitary Latrine (ISL) would be applicable to the housing beneficiaries of Rural Permanent Housing schemes.

6. The Scheduled Caste (SC) and Scheduled Tribe (ST) beneficiaries will be eligible for the additional financial assistance for which orders are being issued separately.

7. The Managing Director, A.P. State Housing Corporation Limited / all the District Collectors / Executive Directors (Housing), shall take necessary further action accordingly.
