ORDER:

The Hon'ble Chief Minister, AP, Hyderabad has made certain announcements for sanctioning certain works during Indiramma Bata in Nellore district, vide 7th read above.

1. The announcements made by the Hon'ble Chief Minister, AP, Hyderabad, were placed before the State Council for the development of SCs and STs in the 2nd meeting held on 21.05.2013 and the same were approved by the State Council for the development of SCs and STs and directed to take up the works under TSP 2013-14 i.e., construction of buildings for Mini Gurukulam at Gudur, Nellore District, AP Residential Junior College for Boys at Chittedu, Nellore district and AP Residential Junior College for Girls at Chandrashekarapuram, Nellore district vide reference 8th read above.

2. After careful examination of the proposal, and keeping in view the decision of the State Council, Administrative sanction is hereby accorded for construction of buildings for Mini Gurukulam at Gudur, Nellore District, A.P., Residential Junior College for Boys at Chittedu, Nellore District and A.P., Residential Junior College for Girls at Chandrashekarapuram, Nellore district as shown in the annexure-1 appended, at an estimated cost of Rs.660.00 Lakhs under TSP 2013-14 scheme of Buildings for School Complex. Adequate budget provision of Rs.160.00 Cr. has been already made available under BE 2013-14.

3. The Commissioner, Tribal Welfare shall take further necessary action and execute the said works in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

4. The expenditure towards construction of the said works shall be debited to the following head of account.
