ORDER:

In tune with Tribal Empowerment Policy, 2010-15 and also in compliance to the 9 point program for tribal development announced by Hon'ble Chief Minister and as part for the Sunnamvarigudem declaration articulated by Hon'ble Chief Minister on 8.8.2012, the Tribal Welfare Department has proposed to strengthen infrastructure of Pre-Matric Hostels as a long term objective of ensuring quality education among STs in the State.

2. The Tribal Welfare Department provided permanent buildings to all Pre-Matric Hostels under various schemes except (19) Pre-Matric Hostels which are now functioning in private buildings.

3. With a view to provide permanent buildings to these (19) Pre Matric Hostels and construction of compound wall (balance length 700 rmt to RJC at G.K.Veedhi) necessary proposals are prepared and placed before the Nodal Agency for TSP with an estimated cost of Rs.100.00 Lakhs per each.

4. The Nodal Agency for TSP in its meeting held on 02.12.2013 after through deliberations, has agreed and recommended for construction of permanent buildings for (19) Pre-Matric Hostels and construction of compound wall (balance length 700 rmt to RJC at G.K.Veedhi) vide reference 7th read above.

5. The State Council for the development of SCs and STs also approved the same vide reference 8th read above.

6. After careful examination of the proposal, and keeping in view the decision of the State Council, Administrative Sanction is hereby accorded for construction of permanent buildings for (19) Pre-Matric Hostels and construction of compound wall (balance length 700 rmt to RJC at G.K.Veedhi) as shown in the annexure-1 appended, at an estimated cost of Rs.1924.00 Lakhs under TSP 2013-14 scheme of Buildings for School Complex. Adequate budget provision of Rs.160.00 Cr. has been already made available under BE 2013-14.

7. The Commissioner, Tribal Welfare shall take further necessary action and execute the said works in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

8. The expenditure towards construction of the said works shall be debited to the following head of account.
