ORDER:

The Tribal Welfare Department in tune with Tribal Empowerment Policy, 2010-2015 and also in compliance to the 9-point Program for Tribal Development announced by Honorable Chief Minister and as part of the Sunnamvarigudem declaration articulated by Honorable Chief Minister on 8-8-2012, the Tribal Welfare Department has proposed to strengthen Infrastructure of Residential Junior Colleges for Girls as a long term objective of ensuring quality education among STs in the State.

1. Buildings for Residential Junior College for Girls at GK Veedhi of Visakhapatnam and Ankampalem of Khammam district have been sanctioned for Rs.330.00 lakhs each. During the execution of the works the need for some more additional infrastructure facilities like Staff Quarters, Compound Wall, Borewell with Motor, Retaining Wall & Electrical Transformer etc., have been realized and due to which the amount required to complete the construction of Mini Gurukulams has increased as shown below:

3. The issue was placed before the Nodal Agency for TSP in its 4th meeting held on 2.12.2013 and after thorough deliberations, the Nodal Agency for TSP has agreed for recommending modifications/alterations of certain sanctioned works of TWD vide its resolution No.31/13 in the reference 8th read above. The State Council for the development of SCs and STs also approved the same vide reference 9th read above.

4. After careful examination of the proposal, and keeping in view the decision of the State Council, revised administrative sanction is hereby accorded for completion of works with additional

infrastructure facilities as shown in the annexure-1 appended, at a revised estimate of Rs.829.00 lakhs and meeting the balance amount of Rs.169.00 lakhs under TSP 2013-14 scheme of Buildings for School Complex. Adequate budget provision of Rs.160.00 Cr has been already made available under BE 2013-14.

5. The Commissioner, Tribal Welfare shall take further necessary action and execute the said works in a time bound manner during the current financial year, 2013-14, through the Tribal Welfare Engineering Department.

6. The expenditure towards construction of the said works shall be debited to the following head of account.
