ORDER :

The Tribal Welfare Department in tune with Tribal Empowerment Policy, 2010-2015 and also in compliance to the 9-point Program for Tribal Development announced by Honorable Chief Minister and as part of the Sunnamvarigudem Declaration articulated by Honorable Chief Minister on 8-8-2012, has proposed to strengthen Infrastructure of the offices of Assistant Tribal Welfare Officers in the State to ensure Good Governance in tribal areas by ensuring effective supervision of tribal welfare hostels and timely disbursement of postmatric scholarships.

2. The Nodal Agency for TSP in its meeting held on 13.05.2013, after thorough deliberations, has agreed and recommended for construction of (64) ATWO Office cum Godowns. The State Council for Development of SCs & STs in its meeting held on 21.05.2013 has approved the proposal of Nodal agency of TSP.

3. After careful examination of the proposal and keeping in view the decision of the State Council, Administrative Sanction is hereby accorded for construction of (64) ATWO Office cum Godowns, as shown in Annexure-I and appended to G.O. at an estimate cost of Rs.9.60 Crores under TSP 2013-14 as adequate budget provision of Rs. 60.00 Crores has been already made available under BE 2013-14.

4. The Commissioner, Tribal Welfare and Engineer-in-Chief, Tribal Welfare shall take further necessary action and execute the construction of the said (64) ATWO Office cum Godowns in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

5. The expenditure towards construction of the said (64) ATWO Office cum Godowns shall be debited to the following head of account.
