### **ORDER:**

The Government of Andhra Pradesh has enacted "The Andhra Pradesh Scheduled Castes Sub-Plan (Planning, Allocation and Utilization of Financial Resources) Act.2013" (Act No.1 of 2013) with an object of ensuring accelerated development of Scheduled Castes (SC) and Scheduled Tribes (ST) with emphasis on achieving equality in the next ten years focusing on economic, education and human development along with ensuring security social dignity and promoting equity among Scheduled Castes and the Scheduled Tribes by earmarking a portion in proportion to population of Scheduled Castes and Scheduled Tribes in the State of the total plan outlay of the State of Andhra Pradesh as the outlay of the Scheduled Castes Sub-Plan (SCSP) / Tribal Sub Plan (TSP) of the State.

2. In tune with Tribal Empowerment Policy, 2010-2015 and also in compliance to the 9-point Program for Tribal Development announced by Hon'ble Chief Minister and as part of the Sunnamvarigudem declaration articulated by Hon'ble Chief Minister on 8-8-2012, the Tribal Welfare Department has proposed to strengthen Infrastructure such as dormitories, dining hall and toilet blocks in the existing Ashram Schools with a long term objective of ensuring quality education among STs in the state.

3. The Tribal Welfare Department is running Residential Schools with the objective of providing better educational facilities to the ST students to improve their literacy and to provide quality education.

4. The Nodal Agency for TSP in its meeting held on 13.05.2013 after thorough deliberations, has agreed and recommended for Construction of buildings for (4) Integrated Residential Schools under RIAD. The State Council for Development of SCs & STs in its meeting held on 21.05.2013 has approved the proposal of The Nodal Agency for TSP.

5. After careful examination and keeping in view the decision of the State Council, Administrative Sanction is hereby accorded sanction for Construction of buildings for (4) Integrated Residential Schools under RIAD, as shown in Annexure-I as appended to G.O. at an estimate cost of Rs.4.00 Crores under TSP 2013-14. Adequate budget provision of Rs. 2.00 Crores has been already made available under BE 2013-14.

6. The expenditure towards construction of the said buildings shall be debited to the following head of account.

4225	- Capital outlay on Welfare of SCs, STs and OBCs
02	- Welfare of STs
MH 800	- Other Expenditure
GH (07)	- RIDF
SH (77)	- Construction of buildings for Integrated Residential Schools
530/531	- Other Expenditure (PLAN)

7. The Commissioner, Tribal Welfare & Engineer-in-Chief, TW shall take further necessary action and execute the construction of the said Integrated Residential Schools in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

8. Since, this item has been approved by the State Council for the Development of SCs and STs vide reference 8<sup>th</sup> read above and as per para (5) of the GO 4<sup>th</sup> read above, this order does not require the concurrence of the Finance Department.
