ORDER :

The Government of Andhra Pradesh has enacted "The Andhra Pradesh Scheduled Castes Sub-Plan (Planning, Allocation and Utilization of Financial Resources) Act.2013" (Act No.1 of 2013) with on object of ensuring accelerated development of Scheduled Castes (SC) and Scheduled Tribes (ST) with emphasis on achieving equality in the next ten years focusing on economic, education and human development along with ensuring security social dignity and promoting equity among Scheduled Castes and the Scheduled Tribes by earmarking a portion in proportion to population of Scheduled Castes and Scheduled Tribes in the State of the total plan outlay of the State of Andhra Pradesh as the outlay of the Scheduled Castes Sub-Plan (SCSP) / Tribal Sub Plan (TSP) of the State.

2. The Tribal Welfare Department in tune with Tribal Empowerment Policy, 2010-2015 and also in compliance to the 9-point Program for Tribal Development announced by Hon'ble Chief Minister and as part of the Sunnamvarigudem declaration articulated by Hon'ble Chief Minister on 8-8-2012, has proposed to strengthen infrastructure of the ITDAs in the State to ensure Good Governance in tribal areas by ensuring effective supervision of tribal welfare activities.

3. The Nodal Agency for TSP in its meeting held on 13.05.2013, after thorough deliberations, has agreed and recommended for Construction of Staff Quarters at ITDA Head Quarters. The State Council for Development of SCs & STs in its meeting held on 21.05.2013 has approved the proposal of Nodal Agency for TSP.

4. After careful examination of the proposal and keeping in view the decision of the State Council, Administrative Sanction is hereby accorded for Construction of Staff Quarters at ITDA Head Quarters, as shown in Annexure-I and appended to G.O. at an estimate cost of Rs.20.00 Crores under TSP 2013-14. Adequate budget provision of Rs. 60.00 Crores has been already made available under BE 2013-14.

5. The Commissioner, Tribal Welfare and Engineer-in-Chief, Tribal Welfare shall take further necessary action and execute the construction of the said Construction of Staff Quarters at ITDA Head Quarters in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

6. The expenditure towards Construction of Staff Quarters at ITDA Head Quarters shall be debited to the following head of account.
