ORDER :

The Government of Andhra Pradesh has enacted "The Andhra Pradesh Scheduled Castes Sub-Plan (Planning, Allocation and Utilization of Financial Resources) Act.2013" (Act No.1 of 2013) with an object of ensuring accelerated development of Scheduled Castes (SC) and Scheduled Tribes (ST) with emphasis on achieving equality in the next ten years focusing on economic, education and human development along with ensuring security social dignity and promoting equity among Scheduled Castes and the Scheduled Tribes by earmarking a portion in proportion to population of Scheduled Castes and Scheduled Tribes in the State of the total plan outlay of the State of Andhra Pradesh as the outlay of the Scheduled Castes Sub-Plan (SCSP) / Tribal Sub Plan (TSP) of the State.

2. The Tribal Welfare Department in tune with Tribal Empowerment Policy, 2010-2015 and also in compliance to the 9-point Program for Tribal Development announced by Hon'ble Chief Minister and as part of the Sunnamvarigudem declaration articulated by Hon'ble Chief Minister on 8-8-2012, has proposed to strengthen planning and monitoring of education activities at ITDA level through a long term objective of quality education among the STs.

3. As part of the plan (9) PMRCs have been established in the tribal predominant areas of the state. Each center needs to improve the infrastructure for training and with an attached hostel at an estimated cost of Rs.50.00 lakhs.

4. The Nodal Agency for TSP in its meeting held on 13.05.2013 after thorough deliberations, has agreed and recommended for improvement to (9) PMRC buildings. The State Council for Development of SCs & STs in its meeting held on 21.05.2013 has approved the proposal of Nodal Agency for TSP.

5. After careful examination of the proposal and keeping in view the decision of the State Council, Administrative Sanction is hereby accorded for Improvement to (9) PMRC buildings, as shown in Annexure-I and appended to G.O. at an estimate cost of Rs.4.50 Crores under TSP 2013-14. Adequate budget provision of Rs. 160.00 Crores has been already made available under BE 2013-14.

6. The Commissioner, Tribal Welfare and Engineer-in-Chief shall take further necessary action and execute the construction of the said improvement to (9) PMRC buildings in a time bound manner during the current financial year through the Tribal Welfare Engineering Department.

7. The expenditure towards construction of the said improvement to (9) PMRC buildings shall be debited to the following head of account.
